

#### DANWADAAG IN BRIEF

- Duration: 2018-2028
- Coverage: South West State, Jubaland, Benadir Regional Administration and Hirashabelle
- Target population: Displacement Affected Communities (internally displaced persons, returnees and host communities), local authorities and informal duty bearers. Specific attention is given to the agency of vulnerable groups including women and youth.
- Partners: International Organization for Migration (lead agency) Norwegian Refuge Council, Concern Worldwide, Regional Durable Solutions Secretariat, Juba Foundation, Gargaar Relief Development Organization, Northern Frontier Youth League and Somali Community Concern

## AREAS OF INTERVENTION





The Danwadaag (meaning common purpose) consortium is supported by UK's Foreign, Commonwealth & Development Office (FCDO), US Agency for International Development (USAID), European Union and World Bank through the Government of Somalia. It aims to enhance progress towards durable solutions and (re) integration for targeted displacement affected communities (DAC). The programme uses an adaptive contextualised approach to ensure the specific needs and priorities of DACs underpin programme design, implementation and learning.

Danwadaag focuseson area-based, government-led and community driven long-term solutions to displacement and connects them to urban development processes ensuring sustainability and impact.

# HOW TO MEASURE (RE)INTEGRATION

Danwadaag has progressed the understanding and evidence-base around this critical issue by investing in a Local (Re) Integration Assessment (LORA). The LORA is a comprehensive data collection tool based on the IASC and ReDSS Solutions framework that monitors key aspects of physical, material and legal safety of targeted households on a yearly basis. The LORA enables evidence generation by the programme to ensure the needs and priorities of DACs are considered in (re) integration at household, community and area level. Specifically, it examines to which extent key variables such as access to employment or land tenure security contribute to more self-reliance and long-term solutions in urban development processes.

#### **KEY DESIGN ELEMENTS**

**Government-led:** Recognizing governments primary responsibility for the leadership of durable solutions processes. Danwadaag supports government to convene and coordinate inclusive processes.

Community Driven and Inclusive: Community action planning brings displacement communities together, improves social cohesion and ensures DACs voices influence programme planning and decision making.

Area Based, Adaptive Approach: Danwadaag focuses on geographic areas to define programme entry points. Danwadaag invests in proactive coordination with humanitarian, Government and development actors to reduce duplications, enhance collaboration and maximise impact for the communities we serve.

**Climate-senstivie:** A long-term adaptive logic and climate-resilient solutions will be prioritised over short-term gains.
